Hotline Hours: Monday through Friday 10 a.m. to 2 p.m. Offers mediation services to consumers who have a billing dispute with their healthcare provider or a coverage dispute with their HMO or health insurance company (if your health plan has refused to cover a medical procedure or pay for a medical service for a consumer; need help resolving a billing dispute with a health care provider, such as a hospital, doctor or dentist; or need assistance resolving a dispute about medical equipment that was defective or was never delivered). Help consumers who have been denied enrollment in a Qualified Health Plan or denied Advanced Premium Tax Credits or Cost-Sharing Reductions by Maryland Health Connection. Maryland law also allows providers to file complaints against insurance carriers on behalf of consumers.
